#### FACTS

#### WHAT DOES JUSTLOANS DO WITH YOUR PERSONAL INFORMATION?

##### Why?

Financial companies choose how they share your personal information. Consumers have the right to limit some but not all sharing. This notice tells you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.

##### What?

The types of personal information we collect and share depend on the product or service you have with us. This information can include:

Social Security number and checking account information

Payment history and income

Employment information and wire transfer instructions

##### How?

All financial companies need to share customers' personal information to run their everyday business. In the section below, we list the reasons financial companies can share their customers' personal information; the reason JustLoans chooses to share; and whether you can limit this sharing.

#### Who is providing this notice?

JustLoans, a business entity of the Wabamun Lake Community District of the Ojibwa Sioux Tribe, is providing this privacy

JustLoans, a business entity of the Warpaint Lake Community District of the Oglala Sioux Tribe, is providing this privacy policy.

#### What we do

##### How JustLoans protect my personal information?

To protect your personal information from unauthorized access and use, we use security measures. These measures include computer safeguards and secured files and buildings.

##### How does JustLoans collect my personal information?

We collect your personal information, for example, when you:

- Apply for a loan
- Give us your income information
- Tell us where to send the money
- Provide account information
- Provide employment information

We also collect your personal information from others, such as credit bureaus, affiliates or other companies.

##### Why can't Limit Sharing?

You have the right to limit only:

- sharing for affiliates' everyday business purposes - information about your creditworthiness
- affiliates from using your information to market to you
- sharing for non-affiliates to market to you

##### What happens when I limit sharing for an account, I hold jointly with someone else?

Your choices will apply to everyone on your account.

#### Definitions

##### Affiliates

Companies related by common ownership or control. They can be financial and non-financial companies. Our affiliates include other business entities of the Oglala Sioux Tribe.

##### Non-affiliates

Companies not related by common ownership or control. They can be financial and nonfinancial companies. JustLoans does not share with non-affiliates so they can market to you.

##### Joint marketing

Companies related by common ownership or control. They can be financial and non-financial companies. A formal agreement between non-affiliated financial companies that together market financial products or services to you.
